Members' Right & Liabilities

Classes of Members include Patron, Art Lover and Artist Life Member.

- a) The committee may select persons of distinction and holding eminent positions to be 'Patrons' of The Bombay Art Society on receiving contribution of ₹ 1,00,000/-
- b) Persons contributing ₹ 25,000/- shall be selected, solely on the discretion of The Bombay Art Society, in the category of 'Art Lovers' and their membership tenure will be for a lifetime.
- c) Persons contributing ₹ 5,000/- shall be selected, solely on the discretion of The Bombay Art Society, in the category of 'Artist Life Member'. Their membership tenure will be for a lifetime.
- d) It is imperative for the person to be above 18 years of age to be eligible to be the member of The Bombay Art Society.
- e) Any change in name, address or other details will have to be communicated through mail or on post to The Bombay Art Society.

Selection of Members:

Members of all classes will be admitted only by the Managing Committee of The Bombay Art Society. Any person desiring to be a member shall apply in writing to the Hon. Secretary of The Bombay Art Society accompanied with subscriptions, which states therein his / her preference of the kind of membership, his / her biodata (copy of attested qualification certificates, viz; Diploma / Degrees / PG), profession and address. The application must be sanctioned by two life members of the society.

The Managing Committee is not bound to assign any reason for its decision in the case of rejected applications.

Members admitted at any time during the year, shall pay the whole amount of the subscription. Subscription once accepted with membership fee shall not be refunded on any account.

Rights of Members:

Patron / Art Lover / Artist Life Member shall be entitled to all the benefits and privileges of The Bombay Art Society which includes; voting at all general meetings of The Bombay Art Society subject to the provision contained in its constitution along with free admission to the exhibition, lectures and meeting. The Bombay Art Society's journal may be given to every such member on payment of charges decided by the Managing Committee. Subject to the provision contained in the constitution, a member shall be eligible for election on the Managing Committee of The Bombay Art Society.
